Airsoft is an extremely fast paced sport as well as physically and mentally demanding. It is a lot of fun but like any other sport, airsoft can be dangerous if ill equipped for or incorrectly played. Rules of conduct have been created and will be enforced in order to allow each and every player to safely enjoy their experience at Sac County Airsoft and Training. Sac County Airsoft and Training will not be held responsible for any injuries or loss of life.

Being unsafe will lead to temporary or permanent ban.

Sac County Airsoft and Training RESERVES THE RIGHT TO REFUSE SERVICE TO ANYONE!

Conduct OFF the field:

- Players are required to transport their airsoft weapons in compliance with the laws of the state of CA. Noncompliance will result in refusal of service. These weapons look real and should be treated as such. EXPOSED AIRSOFT WEAPONS ARE NOT ALLOWED OUTSIDE OF THE FACILITY. Weapons must be transported in non-transparent gun bags, cases, or original boxes.
- Players are responsible for their own equipment, keep your area neat and clean, and put your things away when not in use. Sac County Airsoft and Training is NOT responsible for theft or damaged items.
- Security Footage will not be made available for public use
- Theft and crime will be prosecuted to the fullest extent of the law
- Players are to be safe with their equipment at all times.
 - Treat all guns as if they are loaded.
 - **Guns on safe and fingers OFF the trigger**
 - Chambers cleared and magazines OUT of the gun
 - No pointing your weapons at ANYONE OFF THE FIELD
 - No horseplay or running off the field
 - ABSOLUTELY NO FIRING YOUR WEAPON OFF THE FIELD!!!!
- Lasers are NOT permitted on the premises **without prior approval.**
- Rude behavior towards ANYONE will result and temporary or permanent ban
- Physical or Verbal Fighting is not tolerated
- Profanity will NOT be tolerated. There are children present, set a good example
- Smoking or vaping is only allowed in designated areas.
- Drug and Alcohol usage is NOT permitted at Project N1
- Damage and/or destruction of Sac County Airsoft and Training property will result in Permanent Ban and legal action.
- NO REAL FIREARMS OR KNIVES ARE ALLOWED ON THE PREMESIS



- NO AIRSOFT GUNS WILL EXCEED 350 FPS OR 1.14J. USE OF AN AIRSOFT GUN EXCEEDING THE FIELD LIMITS WILL RESULT IN TEMPORARY OR PERMANENT BAN!!!!
- Sac County Airsoft and Training is a SEMI ONLY Field, NO AUTOMATIC FIRE.
- Players are NOT allowed to fire from the dead box
- Players are NOT allowed to talk to live players while dead. Talking to or signaling live players while dead is considered cheating.
- No sharp or pointed objects on guns.
- BBs may NOT weigh less than .20 Grams.
- DO NOT PICK UP ANYTHING THAT DOES NOT BELONG TO YOU.
- GRENADES AND LASERS MUST BE APPROVED BY MANAGEMENT AT ALL TIMES

Sac County Airsoft and Training will not be held responsible for any lost, stolen, or damaged property and/or injuries and/or loss of life. By signing this I understand and agree and respect the contract and rules to the fullest extent. I agree to respect and be safe to others and myself at Sac County Airsoft and Training. In the event that I break any of these rules or display suspicious behaviors, I authorize Sac County Airsoft and Training Indoor Airsoft Field to remove me from the premises and property without refund or compensation OR detain me until proper authority arrives. This waiver is valid throughout the year of 2021.
